Coming from the South via Highway 99

Exit Highway 99 at Avenue 12.

Turn left onto Avenue 12.

After approximately two miles, turn right onto Highway 145/South Madera Avenue.

Turn right onto Avenue 13/East Pecan Avenue.

After 1.5 miles, the school will be on your right.

Coming from the North via Highway 99

Exit Highway 99 at Almond Avenue.

Turn left onto East Almond Avenue.

Continue on Golden State Drive.

Turn right onto Avenue 13/East Pecan Avenue.

The school will be on your left.

Coming from the Madera Unified District Office (1902 Howard Road)

Go east on Howard Road (toward Pine Street and the railroad tracks).

Turn right onto South Pine Street/Road 26.

Turn left onto Avenue 13/East Pecan Avenue. Continue for 1.5 miles.

The school will be on your right.
